

"Best of Bowland" Photography Terms & Conditions



Forest of Bowland National Landscape

Participants must be 18 years or over.

1. Maximum of one photograph per participant. Photographs must have been taken in the Forest of Bowland National Landscape. Follow this [link](#) to view a map of the Forest of Bowland NL boundary.
2. Photographs do not have to be taken specifically for the Forest of Bowland National Landscape Management Plan Review. Participants can submit photographs taken from past seasons and years in Bowland.
3. Please only submit electronic, high-resolution photographs (minimum file size 1mb - maximum file size 50mb). If possible, 300 dpi and 8-bit.
4. Photographs must not infringe the rights of any other party. Participants must be the sole owner of the copyright, and any other intellectual property rights, in the photograph entered. Participants must have obtained permission to use or feature any people, content or other material, and must have the legal consent of the parents/guardians of any children under 18 who are featured. Subjects of photographs should be made aware that the images may appear on websites and in printed and other media, including social media, and may be shared with other organisations. Further, participants must not have breached any laws when taking their photograph.
5. Participants will retain the copyright of the photograph they submit. By submitting a photograph, participants agree that the image, and any accompanying text, can be used as part of the Forest of Bowland Management Plan 2026-2031 review process. Further, participants grant the Forest of Bowland National Landscape Partnership the right to publish and exhibit their submitted photograph on websites, social media, print, in press releases and other media related to the promotion of the Forest of Bowland National Landscape, and to share them with other relevant organisations. No fees will be payable for any of the above uses. While the Forest of Bowland National Landscape Partnership makes every effort to credit photographers (if consented to do so), including in printed reproductions of their work, we cannot guarantee that every broadcast use of the photograph will include the photographer's name.
6. It is the responsibility of the participant to remove the metadata embedded within the photograph if they do not wish to share this with us. We will store your photographs in the same format that they are uploaded to the website, including any metadata embedded within the image.
7. All submitted photographs will be entered into a prize draw. The number of draws will be dependent on the number of prizes available. A maximum of one prize will be allocated per name drawn. The prize draw will be undertaken by members of the Forest of Bowland National Landscape Unit. Winners will be informed by 30th September 2025.
8. Name and contact information will be kept for the purpose of contacting participants in the event of their entry winning a prize, or if we need to clarify anything relating to their submission with them. By entering a photograph, participants agree to the Forest of Bowland National Landscape Partnership (hosted by Lancashire County Council) collecting, saving and processing their personal data for this purpose.
9. If participants would like their name included alongside use of their submitted photograph (please see Point 5 above) they will need to give specific consent for this when uploading their photograph.
10. The Forest of Bowland National Landscape Partnership reserves the right to remove or refuse any submissions for any reason.
11. Please do not submit a photograph unless you agree to these terms.
